2010-2011 Summary of Changes

- The entire South East Deer Management Region of Fort Hood will be closed to whitetail deer (WTD) hunting commencing with the 2010-2011 season, to include the Archery Only areas. Turkey, feral hog, predator and small game hunting are still authorized. The closure length is three years. At the end of the three-year period, the WTD population will be analyzed and reinstituting WTD recreational hunting will be evaluated for that region. South East Deer Management Region includes the following areas: 30, 31, 32, 33, 34, 35, 36, 37,104,105,114 and 8 South.
 - Turkey is classified as Big Game, turkey hunters in the SE Region will continue to check in/out through Teletrac; selecting Option 2 for unguided Big Game hunting. This procedure is for turkey hunting only. Under no circumstances is hunting of whitetail deer authorized in the South East Deer Management Region; all violators will be prosecuted.
- Currently, hunting fox and bobcat on the installation is prohibited (FH REG 210-25). The initial step to relook
 this prohibition is to survey for both species to determine their population status. This will be conducted
 throughout the month of September, followed by a report in October of Natural Resources Management
 Branch findings with a STAFFED recommended course of action to the Garrison Commander. The decision
 will be posted at the Sportsmen's Center once the process is completed.
- Area 109 is Archery Only for BIG Game (deer & turkey) hunting. Small game hunting will only be authorized using shotgun and shot shells (see Table 2-1 for game/weapons limitations) North of the 40 gridline and East of the 12 gridline.
- Addition of Fort Hood Special 5-Day Small Game/Nongame Hunt Permit for \$40. All eligible
 persons may purchase this permit. All requirements for hunting on Fort Hood still apply: Texas
 hunting license & applicable endorsements, proof of hunter safety certification, and firearms
 registration. Special permit will be for 5 consecutive days and NOT for hunting deer or turkey.
 All categories of Big Game permits are regular price.
- Regional quotas for deer will apply to all Archery Only areas. When a region's quota has been met, ALL areas in that region will be closed to deer hunting.
- Traditional bow hunters will meet the same qualification standards as youth.
- **Guided** reservations for opening day of General Gun Season will commence at 1600 on 4 November 2010. **Unguided** reservations will be on 5 November 2010 at 1600 as usual.

Clarifications

- The Director of Family and Morale, Welfare and Recreation (DFMWR) has the responsibility of approving/disapproving advisory council recommendations. The Fort Hood Hunting & Fishing Advisory Council made the following recommendations:
 - Allow hunters to designate one personal stand in each unguided hunting area and allow the locking of those stands.
 - Establish a minimum 100 yards allowable distance between unguided gun stands and 50 yards allowable minimum distance between archery stands.

The DFMWR has determined that these recommendations are not in the best interest of the program, nor to those whom this program is intended to serve; therefore, has decided to disapprove putting them into effect. Individuals may <u>choose</u> to construct and place stands on Fort Hood based on the knowledge and understanding that those stands will be made available for use by any authorized hunter on a daily basis.

- Unauthorized use of a permit or the Teletrac system can result in administrative action such as suspension or revocation of hunting privileges. Minimum suspension will be 7 days; maximum suspension will be permanent bar from recreational privileges. Length of suspensions and revocation of privileges will be determined on a case-by-case basis. Unauthorized use includes but is not limited to:
 - Allowing the use of one's permit for another hunter's personal gain
 - Using another hunter's permit to block hunting slots when the hunter has no intentions
 of hunting

- Using another's permit as a slot holder: removing a person from the system and putting
 yourself into that slot. Teletrac reports will be used to show an established pattern of
 misuse.
- Making more than (1) one reservation per permit for a guided hunt in the Teletrac system (same day or different day)
- Making more than (1) one reservation per permit for an unguided hunt in the Teletrac system (same day or different day)
- Making a small game Teletrac reservation to Big Game hunt when the area is closed for Big Game hunting
- Making a Teletrac reservation for an open area and actually hunting an adjacent closed area. All hunters are responsible for knowing what area they are physically in.
- Spike deer defined as: a buck deer with no antler having more than one point. Point defined as a projection that extends at least one inch from the edge of a main beam or another tine.
- Corn for deer may be thrown on the ground in the Unguided No Permanent Stands and No Feeders Areas.
- Hunter safety certification deferment available through the state of Texas does not apply on Fort Hood.
- Hunt: to capture, trap, take or kill, and includes any attempts to capture, trap, take or kill.

Reminders


- All personnel who are using their privately owned firearms on Fort Hood are required to
 register their firearms. Registration can be accomplished at the main gate Visitor's Center or
 the Provost Marshall's Office. Personnel must declare any firearm they are
 carrying/transporting if and when stopped at the Access Control Points (ACPs) to Fort Hood,
 when being inspected by ACP personnel, when inspected at any other checkpoint on the
 installation or when stopped for random inspection.
- All archery hunters must qualify annually in order to archery hunt on Fort Hood; only exception is if you
 registered a deer or turkey harvest by archery in the previous season; you must show proof on previous
 season's hunting permit. Hunters using crossbows must also qualify. Archery qualifications will be with
 broadheads NOT practice tips.
- Teletrac check out time for authorized users is midnight; except for Big Game hunters. Teletrac
 check out time for Big Game hunters is 2100. Big Game hunters tracking wounded game past
 2100 will remain checked into Teletrac for Big Game hunting and notify the game wardens by
 calling 254-535-1050.
- Fort Hood is participating in the Late Antlerless and Spike deer season Jan 3-16, 2011 as long as a quota remains to support the season.
- Scheduled starting time for the morning guided hunts will be 0300 hours (3:00 a.m.) for opening weekend and 0400 (4 a.m.) thereafter.
- Use Area Access Permit numbers for ALL TeleTrac reservations. Youth Big Game hunters will be assigned their own Area Access Permit number. NO big game hunting (deer & turkey) access is authorized through TeleTrac selecting Area Access; you must select Guided or Unguided.
- If you accidentally shoot an animal with an electronic monitor, you **MUST** turn in the monitor to the Natural Resources Management Branch, Bldg 1939.
- Hunters are not authorized to have multiple weapons while hunting. For example: rifle while hunting unguided; shotgun while guided rifle hunting or any firearm while archery hunting.
- Archery Only areas authorized the use of shotgun with shot shells for Turkey hunting, small game and pigs are: 8N, 8S, 37, 109 (with restrictions), 200, 203, 300, 305 and 306; NO slugs.
- Unguided hunters must know the authorized deer quota for the area they are hunting. Unguided deer harvest quotas are updated daily during the Archery Only and Gun Seasons on the DEER QUOTA HOTLINE 254-532-9425.
- When you purchase any Fort Hood recreational permit, you are responsible for the knowledge of all applicable rules, laws and regulations that pertain to the activity you

are conducting or participating in. Violations of said rules, laws and regulations are punitive and violators can be subject to all or parts of the following actions: citation, prosecution, suspension or revocation of privileges.

- During the General Fall Season, Guided Areas are not hunted as unguided areas for deer.
- IAW AR 215-1 MWR services may not be used for personal gain. Unauthorized guide services are prohibited.

SPECIAL ANTLER RESTRICTIONS: There are special restrictions for buck deer on Fort Hood. The bag limit is **two legal bucks.** A legal buck deer is defined as having:


- A hardened antler protruding through the skin AND
- At least one unbranched antler; OR
- o An inside spread measurement between main beams of 13 inches or greater
- To determine if a buck has an inside spread measurement of at least 13 inches, look at the distance from ear-tip to ear-tip on a buck with ears in the alert position (see illustration).
- **Definition of a point:** A point is a projection that extends at least one inch from the edge of a main beam or another tine. The tip of the main beam is also a point.








Legal: at least one unbranched antler Legal: at least one unbranched antler

INTRODUCTION

The Fort Hood Sportsmen's Center encourages and furthers the interest of its patrons in hunting, fishing, sport shooting and other outdoor recreational activities. In support of DFMWR's mission, this facility is dedicated to providing quality programming and customer service.

The Fort Hunt Hunting & Fishing Advisory Council has been reestablished. Patrons may submit suggestions for consideration at the Sportsmen's Center or online at www.forthoodhunting.com. The Director of Family and Morale, Welfare and Recreation (DFMWR) has the responsibility of approving/disapproving advisory council recommendations. The council meets at least quarterly; dates are posted at the Sportsmen's Center.

This facility and its' programs are open to the public. Non-affiliated civilians registered with the Sportsmen's Center may be eligible for an extended vehicle pass to expedite entry onto Fort Hood. A memo (obtained from the Sportsmen's Center), proof of owner's valid vehicle registration and insurance must be presented to the Visitor Center at the main gate. Privately owned weapons may be registered at the main gate Visitor's Center. Access policies are subject to change without prior notice.

All participants must be mindful of the land/properties they are using, adhere to all safety regulations, practice sound ethics, and be courteous sportsmen/women. Good sportsmanship includes being respectful of others and practicing hunter etiquette. Everyone should strive NOT to do anything illegal, immoral or unethical.

GENERAL INFORMATION

This guide is established in accordance with AR 200-1, AR 210-9, AR 215-1, AR 350-19, FH REG 210-3 and FH REG 210-25. Fort Hood abides by state and federal regulations; however, have the authority to be more stringent.

The Sportsmen's Center is responsible for issuing Fort Hood hunting, area access, fishing, and ATV permits and will conduct the Fort Hood Hunt Program and the Area Access Program. Fort Hood permits are not issued by mail. Possession of multiple permits is prohibited.

As these publications apply, all recreational users will be responsible for the knowledge of:

- a) DFMWR Annual Hunting, Fishing and Area Access Guide
- b) Texas Hunting and Fishing Regulations in the Texas Parks & Wildlife Outdoor Annual
- c) Fort Hood Circular 210-10-22 (Hunting & Fishing Bag Limits and Seasons)

We remind you that utilization of training areas for training and government business takes priority over scheduled recreational activities. Your patience, cooperation, and understanding are appreciated as we conduct our programs under these circumstances. Fort Hood must ensure the sustainability of its primary military mission, which is training.

DPW/Natural Resource Management Branch (NRMB) determines the annual deer and turkey harvest quotas based on current statistics. Each person may harvest Big Game with a maximum of two bucks meeting criteria, one doe, one exotic, and three turkeys on Fort Hood, one of each species per hunting period. It is the hunter's responsibility to know whether an area he/she is hunting is a buck or doe area; all initial harvest quotas are posted then updated at the Sportsmen's Center. The hunt proceeds until harvest quotas are met, the last scheduled hunt day, or as determined by the Directorate of Family and Morale, Welfare, and Recreation (DFMWR). Individual areas may be closed even though they have not met their harvest quota if their assigned region has met or exceeded its quota. However, there are NO harvest limits for feral hogs. A hunter may harvest as many hogs as desired year round by authorized means.

Firearms Registration:

Personnel who are using their privately owned firearms on Fort Hood are required to register their firearms at the main gate Visitor's Center or at the Provost Marshall's Office. Personnel must declare any weapon they are carrying if and when stopped at the Access Control Points (ACPs) to Fort Hood, when being inspected by ACP personnel, when being inspected at any other checkpoint on the installation or stopped for random inspection. This requirement will be strictly enforced. All ACPs may be used to transport a firearm onto the installation, <u>Use of ACPs is mandatory for entrance into cantonment areas</u>. You are reminded that any <u>firearm being transported on Fort Hood must not be loaded</u>, Weapons may be stored in the passenger compartment of a vehicle if the weapon is in a locked box or container designed to secure firearms as opposed to all weapons stored in a trunk. <u>Firearms must not be readily accessible by persons while in the vehicle.</u> All vehicles are subject to search. Any changes to these procedures will be posted at the Sportsmen's Center. Archery equipment and crossbows are not required to be registered on Fort Hood.

Area Access Permits: DFMWR, Recreational Activity Fee \$10

Area Access Permit fee exceptions:

- (1) All persons 16 years and younger will be registered under their sponsor's permit at no charge; however, once an individual turns 17 years of age, he/she must obtain his/her own Area Access Permit.
- (2) All persons purchasing a Fort Hood hunting or fishing permit will be issued an Area Access Permit at time of said purchase at no additional charge.
- (3) Cattlemen registered with the Central Texas Cattlemen's Association (CTCA) with authorized access to Fort Hood to tend cattle. Persons must be on the official roster provided by the CTCA.
- (4) Persons born before September 01, 1930.
- (5) Mentally disabled person registered under a responsible adult who has an Area Access Permit

NOTE #1: No portion of the \$10 Area Access Permit fee will be refunded if a person initially purchases an Area Access Permit and at a later date purchases a Fort Hood hunting or fishing permit. It is in your best interest to decide which programs you will participate in prior to making any Fort Hood permit purchases.

NOTE #2: All categories of hunt permits will be \$10 less starting January 03, 2011; except for the Special 5-Day Small Game/Nongame Hunting Permit.

NOTE #3: Soldiers on two weeks deployment R&R leave will receive a 50% discount for hunting permits for his/her category with copy of deployment R&R leave orders except for the Special 5-Day Small Game/Nongame Hunting Permit.

All fees are subject to change on an annual basis. DFMWR recreational activity fees are utilized to support requirements for supplies, labor, facility, equipment, and other related expenses. The Sportsmen's Center does not receive any APF (tax dollar) funding and must be self-supporting.

Natural Resource Management Branch permit fees are utilized to support administration, habitat improvement, fish and wildlife management, fish stockings, and other related expenses. The fee structure for each permit year will be published in the DFMWR Annual Hunting, Fishing & Area Access Guide. All fees are collected concurrently: DPW/Natural Resource Management Fee pursuant to the Sikes Act and the DFMWR/Recreational Activity Fee pursuant to AR 215-1.

All categories of valid permits that are lost or destroyed may be replaced at the Sportsmen's Center Pro Shop with proof of validation. Replacement fee will be \$3.00 per permit.

ELIGIBILITY FOR PERMIT CATEGORIES

Hunter Education Course:

- a) As per AR 350-19, it is **mandatory for all hunters** to have the Hunter Education Certification and present proof in order to hunt on the military installation.
- b) This went into effect at Fort Hood on 1 September 1999.
- c) Most states have approved courses available at a nominal fee, and recognize each other's courses. Fort Hood recognizes all other states' courses; but documented proof must be presented.

Category I = Active duty military personnel E5 and above and their eligible family members

Category I (A) = Active duty military personnel E4 and below and their eligible family members

Category II = DA civilian personnel, retired DOD personnel including retired military (all ranks), APF and NAF civilian personnel including AAFES personnel regularly employed on Fort Hood for a minimum of 24 hours per week, and all eligible family members from each of the listed sectors. Category II **does not** include contract personnel unless also retired military.

Category III = All other persons, including Fort Hood personnel working less than 24 hours per week, contractors, concessionaires, and their employees. Category III includes DOD civilians not regularly employed on Fort Hood.

Youth, Big Game = All categories of youth age 16 and under to age 8 years

Youth, Small Game = All categories of youth 16 years and under to age 8 years **Children under 8 years of age are not authorized to hunt on Fort Hood.**

Fishing Permit = All persons. **Exceptions:** youth under 17 years of age and adults 65 years of age or older are not required to possess a Fort Hood Fishing Permit; you are required to possess an Area Access Permit and a Special State Fishing License if you were born on or after 1 September 1930.

Possession of a Fort Hood permit (hunting, area access or fishing) does not guarantee use of Fort Hood property for recreational activity. Authorizations may be limited; access to game, fish or other resources may be closed without advance notice or refund. Failure to comply with applicable statutes and regulations or falsifying permit information is grounds for revocation of Fort Hood permits without refund, and may result in criminal prosecution or administrative separation. Restrictions comply with federal and state regulations and, in some instances, may be more restrictive.

AREA ACCESS PROGRAM

DFMWR/Sportsmen's Center has the mission of controlling authorized recreational access into all maneuver training areas within the boundaries of Fort Hood.

The Area Access Control Center (AACC), which carries out this mission:

- Is located in building 1937 Rod & Gun Club Loop
- Manages the Area Access Program
- For Area Access Permit issue, has operating hours of:

a) Monday-Friday	0800-1800
b) Saturday & Sunday	0700-1800
c) Fourth of July and/or observed holiday	Closed
d) Thanksgiving Day	Closed
e) Christmas Eve & Christmas Day	Closed
f) New Year's Eve & New Years Day	Closed
g) Posted Training Holidays	0800-1500

h) On Monday, Tuesday, and Wednesday during off-season months of January, February, March, June, and July, the AACC is open 0800-1500. The hours on the remaining days will be the same. Any changes to these operating hours will be posted at the Sportsmen's Center, Bldg. 1937, prior to implementation.

All persons accessing Fort Hood lands for recreational or other authorized use are responsible for complying with this guide and other recreational use regulations.

Penalties for violations of statutes, guidelines, policies, and regulations apply to both military and civilian personnel and include a full range of administrative, statutory, and regulatory actions. Unauthorized access constitutes trespassing and violations will be referred to the United States District Court as deemed appropriate.

Registration:

- All persons wishing to conduct any recreational activity within the Fort Hood Training Areas must be registered in the Area Access Program.
- A \$10 fee will be charged for the Area Access Permit with the following exceptions:
 - a) Persons under 17 years of age will be registered under their sponsor's permit at no charge.
 - b) Persons purchasing Fort Hood hunting or fishing permits will be issued an Area Access Permit at no additional charge.
 - c) Cattlemen and their employees registered with the CTCA, having authorized access to Fort Hood lands to tend cattle, will be issued a permit at no charge. However, if these individuals desire to conduct any recreational activity on Fort Hood, they must purchase each appropriate permit and possess all required documentation.
 - d) Area Access Permits will not be prorated regardless of when issued.
 - e) Lost or destroyed Area Access Permits may be replaced for a \$3 fee with proof of validation.
- The AACC permits are issued for 1 year, or until 31 August.
- Registration requires an individual to provide:
 - a) Picture and identification
 - b) Name
 - c) Social Security number
 - d) Home, work, and cell phone numbers if applicable
 - e) Vehicle Information:
 - (1) Make
 - (2) Color
 - (3) Model
 - (4) Year
 - (5) License plate number
 - (6) State of registration

NOTE: If the state registration is in the name of an individual other than the applicant, applicant's spouse a notarized statement, power of attorney, or a lease agreement from the owner/agency specifying the inclusive dates for which permission to use the vehicle has been granted is required to be in the immediate possession of the applicant. The responsible accompanying adult may carry a minor's permit.

 Complete and sign FHT Form 210-X9, Part 1 (Fort Hood Area Access Registration), Section I (Release and Hold Harmless Agreement) and if applicable, Section II, which will be maintained on file with the AACC.

NOTE: Signing the FHT Form 210-X9, Part 1, affirms that the applicant has received the DFMWR Annual Hunting, Fishing, & Area Access Guide, understand the polices, and assumes all responsibility while in the training areas.

- If applicable, complete FHT Form 210-X9, Part 2 (Area Permit). While a field, all users must display their vehicle area access permit in the windshield/dash of their vehicle where it may be easily checked.
- Complete and sign FHT Form 210-X9, Part 3 (Area Permit). Part 3 shall be retained in the immediate possession of the applicant.
- Area Access Permits will:
 - a) Not be loaned to another person
 - b) Not be utilized by unauthorized individuals
 - c) Be safeguarded to prevent loss
- FHT Form 210-X9, Part 1, Section II, must be initiated by a parent, legal guardian, or designated adult.

Note: A person requesting registration of a minor who is not their son, daughter, stepchild, grandchild or adopted child, must present a FHT Form 210-X9, Part 1 signed by the parent or legal guardian of the minor.

Training Area Access:

- Public use of Fort Hood's natural resources is a controlled activity and may be closed without advance notice for training, safety, security (Force Protection), or at the convenience of the government.
- The conduct of uncontrolled or unscheduled outdoor recreational activities within the installation's training complex is prohibited. However, contractual activities and certain guided outdoor and recreational activities are permitted.
- Fort Hood airspace is strictly managed. Prohibited above or within the live fire training and maneuver training areas is the unauthorized operation of the following:
 - a) Civilian aircraft
 - b) Hang gliders
 - c) Homebuilt aircraft, ultra lights, etc.
 - d) Model rocketry
 - e) Nonmilitary remote controlled aircraft
- Other prohibitions on Fort Hood properties:
 - a) Use of metal detectors. This policy is necessary to protect the operators of metal detectors from accidentally detonating unexploded ordnances equipped with electric fuses and to protect the numerous valuable archeological sites.
 - b) Excavating, digging for or otherwise removing, archeological resources or cultural artifacts.
 - c) Recreational cave or rock shelter exploration. Do not enter caves, disturb cave sites or fauna found in them, dump trash in caves, or vandalize/tamper with cave gates.
 - d) Trailblazing or construction of new roads is prohibited except as surveyed and approved by DPW. Use existing roads and tank trails.
 - e) Driving or parking vehicles on dams.
 - f) Remote or radio-controlled model watercraft, propelled by gasoline on all ponds or lakes.
 - g) Recreational use of off road autos: 4x4 or 4x2 vehicles is strictly prohibited except when a 4x4 program has been approved and established. No such program is in effect at this time. Dirt bikes and any all terrain vehicles (ATVs) are ONLY authorized in designated ATV Area 111. ATV permit fees apply and can be purchased at the Sportsmen's Center.
 - h) Carrying of firearms or storage of firearms in vehicles unless on an authorized hunt or to and from the authorized privately owned firearms range.
 - i) Target practice of any type, except for Pilot Knob Sportsman Range. No BB or pellet guns are authorized in Fort Hood training areas at any time.
 - j) Campfires and bonfires are prohibited in all training areas except as authorized in designated camping areas. Authorized fires must be contained and controlled within a diameter no larger than three feet, surrounded by either an earthen, rock or metal border. Commercial camp stoves and barbeque grills are permitted, provided appropriate safety precautions are observed.
 - k) Camping except as authorized at
 - Belton Lake Outdoor Recreation Area (BLORA)
 - By reservation in Camp Finlayson and Camp Arrowhead
 - While fishing designated "No check in/out" fishing ponds/lakes, and Area 8 at water's edge. (Primitive shelters only.)
 - Cutting of standing trees. Gathering of downed/dead wood for removal as firewood, except for use in authorized contained/controlled campfires. Willful destruction or damage to trees by vehicle or other means is prohibited.
 - m) Entry into contaminated, dedicated impact area (Permanent Dudded Area 94 in the live fire training area) is strictly prohibited and will remain off-limits to all recreational and contractual activities.
 - n) Swimming is not authorized in any natural waters of Fort Hood, except within BLORA at designated areas.
 - o) Littering. Protect natural resources by properly disposing of any trash. If no trash receptacles are available or if they are full, take it home with you. You are responsible for any items you brought.
 - p) Digging or otherwise removing living plants, sod, topsoil, sand, rocks, fossils, or artifact resources.
 - q) Digging or other means of soil excavation without a DPW digging permit (FH Form 200-X10) IAW FH REG 200-1, to include soil preparation for wildlife food plots. Digging permit must be obtained in advance. In addition, seed mixtures used for approved food plots must contain only native species

- or annual non-persistent species (such as oats or wheat) that have been specifically approved by Natural Resources Management Branch.
- r) Disturbing or destruction of any Endangered Species Habitat

WARNING: Never enter the Live Fire Training Areas without approval from Range Control, 254-287-3321, or a personal visit (Bldg. 56000) to receive authorization as applicable. Authorization period will be determined by Range Control.

- Recreational access into training areas must be accomplished through the automated Teletrac system (see instructions and codes in this guide), unless otherwise instructed by Area Access Control Center during periods of maintenance or upgrades when the Teletrac system is unavailable. During these periods call 254-287-5847 to gain access.
- Each individual must have clearance prior to entering any training area and is responsible for checking out of the area/areas by 2400 daily. If authorized to stay in the area past 2400 hours, each individual must recheck into the area/areas. Only exceptions are CTCA members who will check in/out telephonically by calling 254-287-5847, individuals fishing in "No Check In/Out" fishing ponds and lakes as listed in this guide, and children under 17 years of age (they will be considered guests of the sponsor with a Teletrac reservation); however, if the individual conducts any activity other than fishing, the individual must check in and out of the Teletrac system.
- Penalties for failure to clear area/areas:
 - a) First Offense: warning
 - b) Second Offense: 30 days suspension
 - c) Third Offense: suspension of privileges for remainder of permit validation or other designated period of time
- Accessing training areas for recreational activities without authorization, or obtaining clearance under false pretenses from AACC and/or Range Control, and failure to obey applicable laws and regulations will subject violator to: arrest by Game Warden, fines, and suspension of recreational access privileges.
- A permanent bar may be immediately imposed for a serious offense, in which case the violator will also be considered for permanent barring from Fort Hood.

NOTE: In all cases, the individual's area access permit will be deactivated in the Teletrac system. Reasonable attempts will be made to inform the individual of any penalties and actions pending and/or taken; however, if for any reason contact cannot be made, the individual still receives the penalty.

- When notified of a **suspension or bar**, the individual must turn in to AACC within 72 hours from the time of notification of the bar, the following:
 - a) The FHT Form 210-X9, Part 2. If applicable, the spouse may retain his/her access permit if also registered in the Area Access Program.
 - b) The FHT Form 210-X9, Part 3 (Vehicle Pass)

Failure to comply is a violation and will result in the penalty progressing to the next suspension or bar period. During the suspension or bar period, the individual is forbidden to access the Training Areas for recreational purposes at any time, either alone or as a guest of another person; violation of the bar constitutes trespassing. Appeals may be submitted in writing through the Sportsmen's Center to the Directorate of Family and Morale, Welfare, and Recreation (DFMWR).

- Typical recreational activities authorized in the maneuver training areas include, but are not limited to:
 - a) Bird watching and/or photography
 - b) Camping, which is authorized only at BLORA, by reservation in Camp Finlayson and Camp Arrowhead, designated "No check in/out" fishing ponds/lakes, and Area 8 at water's edge. Authorized camping is limited to primitive shelters (tents, sunshades, portable cabanas). The use of RV's and camper trailers is restricted to BLORA.
 - c) Dog running/walking/training. Dog training for hunting purposes also requires the trainer to have a valid State hunting/trapping license and Fort Hood hunting permit. All dogs (including hunting dogs) brought on the installation must meet all current vaccination requirements as set forth by the Texas Health & Safety Code or Fort Hood Regulation 40-5. This includes wearing a current rabies vaccination tag.

- d) Hiking, jogging, running
- e) Horseback riding; owners must have proof of negative Coggins test in their possession
- f) Hunting and related activities such as scouting
- g) Gathering of edible plant material (e.g. pecans, berries) is allowed for personal use only and may not be used for commercial purposes. Gather pecans from the ground only. Gathering plant material by climbing or thrashing trees, or using mechanical equipment, or any other practice that could in any way damage trees is strictly prohibited. Possession limit for edible plant material is one gallon per person per day.
- h) Picnicking
- i) Rappelling
- j) Mountain biking/bicycling
- k) In December each year, one cedar tree (juniper) may be cut per family for personal use and one cedar tree may be cut for each military office or dayroom use. Authorized areas are publicized each November. Cut the cedar at the base and remove all foliage from the stump.
- There are access roads that afford passage to the public through the Maneuver Training Areas. An Area Access Permit is not required, provided personnel and vehicles do not leave the roadway. All paved roads and the following improved roadways:
 - 1) Ammo Road
 - 2) Antelope Road
 - 3) Ivy Mountain Road
 - 4) Liberty Hill Road
 - 5) Manning Mountain Road
 - 6) Maxdale Road
 - 7) Nolan Creek Road
 - 8) Nolanville Road
 - Royalty Ridge Road (Between West Range Rd. and Old Georgetown road)
 - 10) Royalty Ridge Road to Walker/Springhill Cemetary
 - 11) Shell Mountain Road
 - 12) Brookhaven Road

FISHING INFORMATION

All persons fishing lakes, ponds, and streams of Fort Hood must possess a valid Texas State Fishing License (except those exempted by the state), Area Access Permit and the Fort Hood Fishing Permit. However, no Fort Hood Fishing Permit or Area Access Permit is required if a person is fishing the waters of Belton Lake within the confines of BLORA, only a state fishing license is required and a daily entry receipt if applicable. Only a state fishing license and Area Access Permit is required if a person is fishing the waters of Belton Lake adjacent to Training Area 8 East of Curry Crossing (no Fort Hood Fishing Permit is required for this area).

All persons will abide by State/Fort Hood bag limits, possession limits, and Area Access procedures as well as all State and Federal fishing regulations. The lakes, ponds, and streams closed to fishing will be identified by "NO FISHING" signs.

Manually propelled boats are authorized on most Fort Hood lakes, ponds, and streams. Those prohibiting boats will be posted with "NO BOATING" signs. III Corps & Fort Hood Circular 210-10-22 identifies locations where boats or flotation devices are prohibited. Fishermen may use boats propelled by electric trolling motors on all lakes and ponds except Cantonment B (Kid's Pond); boats propelled by motors must have current registration in accordance with state law. All motorized boats (including electric) must have Texas boat registration and all boating safety devices that are required by state law.

Access to "No check in/out fishing ponds/lakes" will be by the most direct route from the point of leaving public roadways except Landfill Lake will be accessed by designated route only.

Fort Hood observes the annual State Free Sport-fishing Day which is on the first Saturday of June. State fishing licenses or Fort Hood fishing permits are not required while sport fishing on that day. Valid Area Access Permit (FH Form 210-X9) is required. A special one-day Area Access Permit will be available free of charge but must be obtained from the Sportsmen's Center prior to participation.

Cantonment B Pond is designated as the "Kids' Pond". All adults must be accompanied by at least one fishing youth 16 years old or under. Adults may fish if they meet the fishing child requirement. All must have valid Area Access Permit and adults must have valid Texas fishing license (unless exempt) and Fort Hood Fishing Permit. Children must be supervised (in direct sight) at all times.

PROHIBITED ACTIONS:

- 1. Use of any boats or flotation devices on Cantonment B Pond
- 2. Use of gasoline-powered boat motors on all lakes and ponds, except Belton Lake.
- 3. Driving or parking vehicles on dams.
- 4. Trotlines, throw lines, jug lines, and shocking devices in lakes or ponds. Trotlines are authorized in the Cowhouse Creek East of Curry Crossing and the Leon River.
- 5. Releasing live bait in lakes and ponds. Releasing any aquatic species into Fort Hood waters without written permission from DPW, Natural Resources Management Branch.
- 6. Swimming except at BLORA's designated areas.
- 7. Littering is prohibited. All items brought to the pond/lake by users must be removed upon departure. Minimum fine \$125.
- 8. Use of illegal devices as identified by federal and state laws.
- 9. Possession of fish or aquatic life without fishing or hunting permit as required.

- 10. Fishing West of Curry Crossing in the Live Fire Training Area.
- 11. No BB or pellet guns are authorized in Fort Hood training areas
- 12. Taking of fish that does not meet size limits, bag and possession limits
- 13. Taking of fish without a state license (unless exempt) and required Fort Hood permits

During the Fall Gun Hunting Season, access into Guided Hunting Areas under the Area Access program for activities other than hunting is between 10 am and 2 pm only on scheduled guided hunt dates; normal access is authorized during non-guided hunt dates. Exception to this is "No check in/out" ponds/lakes.

DPW/Natural Resource Management Branch is responsible for stocking selected lakes and ponds on Fort Hood. A current list of stockings by area, date, type of fish, and number of fish is posted on the bulletin board at the Sportsmen's Center, Bldg 1937 or Bldg 1939, DPW/Natural Resource Management Branch or www.forthoodhunting.com. A forecasted stocking schedule is not available.

NOTE: Lawful archery equipment may be used to take NONGAME fish only.

Area Access Special Procedures:

The Central Texas Cattlemen's Association (CTCA) will provide a list to the Sportsmen's Center/AACC of its' members and employees who utilize Fort Hood Training Areas for their livestock. The list will:

- Be validated annually
- Be revised as necessary
- Filed with the AACC
- Reflect each member's
 - a) Name
 - b) CTCA permit number
 - c) Home telephone number or point of contact
 - d) Estate serviced
 - e) Description and license number of vehicles used

NOTE: CTCA members are subject to rules and regulations as recreational users are and will comply with AACC established guidelines and procedures. A cattleman's Area Access Permit is for working cattle only. CTCA members who wish to recreate on Fort Hood must purchase appropriate recreational permits.

Access by organizations

- a) Military and Civilian organizations desiring the use of Training Areas for non-military events must submit a written request through the Sportsmen's Center/AACC not less than 30 days prior to the event date. The Sportsmen's Center/AACC will initiate coordination/approval through DPW/Natural Resource Management Branch, DPW/Environmental Section, DFMWR, Game Wardens and Range Control.
- b) Upon receiving approval, and prior to the start of the event, the organization may obtain Release and Hold Harmless Agreements from the AACC; which will be effective only for the duration of the event and will be returned to the AACC at the conclusion of the event. All participants must be registered in the Area Access Program and fees will apply.

Safety:

- Accident prevention is the number one priority. Safety is everyone's responsibility. To avoid injuries and possible loss of life, all recreational activities must be accomplished in a safe and responsible manner.
 - a) Individuals are responsible for familiarity with all applicable statutes, regulations, and procedures to follow pertaining to proper conservation practices, training area access, and water safety.
 - b) The use or possession of alcoholic beverages is prohibited while conducting any hunting activity in the Fort Hood training areas.
 - c) Beware of abandoned wells, water crossings, duds, and poisonous snakes.
 - d) Report violations to

NOTE: Should you have problems with checking in or out with Teletrac call the AACC number, 254-287-5847. Leave a message if after operating hours and make sure to include your name, Area Access Permit number and the problem you were experiencing.

NOTE: If the number you are dialing does not answer, dial a number from another series. Periodically a series of numbers will be inoperative but one of the other series should work.

Instructions for Teletrac Area Access HUNTING (ALL hunting other than deer & turkey):

Note #1: All small game/nongame hunters will make reservations for One day only. Exception = raccoon hunters may select two consecutive days to accommodate night hunting.

Note #2: Feral hog hunters may select two consecutive days to accommodate night hunting.

Note #3: Coyote hunters may select two consecutive days to accommodate night hunting.

- 1. Dial one of the telephone numbers; the next available line will pick up.
- 2. To check in or out push 1.
 - a. Punch in your Area Access Permit number followed by the (#) pound sign.
 - b. Press 4 for Area Access HUNTING.
 - c. Punch in your area selection code just as it appears on the code table, making sure to include all symbols. A voice will repeat your area selection; press 1 if correct or press 2 to reenter. Do not push the keys too fast or the system will not recognize your selection. There is a voice prompt for the next number. You must always push the # key at the end of your selected area code.
- 3. The voice will verify your area selection. You must select a date for your reservation. For example, if you wish to select September 01, 2010, you will push 0901 on your phone and push the # key. The system will verify your date: push 1 if correct, push 2 to reenter. Hang up if done.
- 4. A voice will ask if you want to check someone else into the same area, press 2.
- 5. Put in the new permit number (or your number if you wish to select multiple areas) followed by the # sign and continue following prompts.
- 6. An individual may select a maximum of (3) three open areas in the Area Access Program for **Small Game/Nongame hunting** at any given time.

GENERAL HUNTING INFORMATION

All hunters are required to have on their person while hunting, the following:

- Proof of Hunter Education Certification
- A valid Fort Hood hunting permit
- A valid Texas hunting license.

- Valid Texas License Endorsements as appropriate for designated seasons
- Valid Area Access Permit
- Fort Hood firearms registration

The hazards associated with hunting <u>during the General Deer and Turkey Season</u> necessitate the requirement for all hunters (regardless of hunting program participating in) to wear a minimum of 400 square inches (total) of hunter's orange on the head and upper torso. (Minimum of hat and vest.) Archery hunters must wear the required hunter orange at least to and from their hunting stands.

No hunter is authorized to have more than one guided or one unguided big game hunting Teletrac reservation at any given time. No hunter is authorized to have concurrent reservations for big game hunting and small game hunting. If any hunter obtains dual hunting clearances for the same and/or different hunt areas for big game hunting and small game hunting, the big game hunting clearance will be automatically **INVALID**.

Hunters may not have multiple weapons in their possession/vehicle while hunting. For example: no shotgun while guided rifle hunting and no rifle while unguided hunting. No firearms are authorized at all while archery hunting.

If hunting is authorized in Live Fire Training Areas, these areas will always be guided. Hunters desiring to hunt in open/cold Live Fire Training Areas must attend Live Fire Training Area Guide's Safety Class offered by the Sportsmen's Center/Hunt Control. Before an area clearance will be honored by G3 Range Division, one hunter (who will be designated as the guide within a hunting party) must have attended this class. Hunting parties will not exceed 4 persons. Hunters participating in the Guided Rifle Deer & Turkey or Guide Feral Hog Hunt Programs will not be required to meet this requirement; they will be assigned to qualified guides.

All Live Fire Training Area (LFTA) deer guides are required to attend the Live Fire Training Area Guide's Safety Class before they will be authorized to serve as a deer guide in the Guided Rifle Deer & Turkey Hunt Program.

Individuals attending a Live Fire Training Area Guide's Safety Class will be posted on a roster of individuals authorized to enter the live fire training areas. Hunt Control will provide an updated list to G3 Range Division, as required.

Any violation of hunting, fishing, or recreational access procedures or regulations (Fort Hood, Federal, or State) will be grounds to revoke Fort Hood land use privileges.

Legal shooting hours for all Game Animals and Non-migratory Game birds: from one-half hour before sunrise to one-half hour after sunset unless otherwise stated. Legal shooting hours for migratory game birds is from one-half hour before sunrise to sunset. During the Special White-winged dove season: noon to sunset.

PROHIBITED ACTIONS FOR ALL HUNT PROGRAMS:

- 1. Shoot in an unsafe manner. Hunters WILL NOT shoot unless the target is clearly identified and lane of fire is clear.
- 2. Possess a loaded weapon in or on vehicles.
- 3. Access training areas by boat for the purpose of hunting, except when hunting waterfowl.
- 4. Hunt from a vehicle, boat, flotation device, or aircraft or airborne device, except as authorized for legal waterfowl hunting.
- 4. Shoot from a vehicle. NOTE: The Sportsmen's Center may authorize an individual with a bona fide disability and physician's certification to use a vehicle as a shooting stand.
- 5. Hunt, shoot, or possess a firearm in an "Archery Only" area except as designated in this guide.
- 6. Possess a weapon in a "No Hunting" area or within 330 yards (300 meters) of Gray Army Airfield or Hood Army Airfield.
- 7. Shoot or aim toward any boundary, person, building, structure or vehicle that is within range of the weapon or load; projectiles cannot cross any perimeter boundary.
- 8. Shoot on, along, or across any maintained road or reservation boundary.
- 9. Rifle hunt within 330 yards or within 110 yards with limited range weapons, of maintained roads, reservation boundaries, borders or fence lines, Camp Finlayson and Camp Arrowhead except as authorized on the guided rifle or guided limited range hunt.

- 10. Hunt within 550 yards (500 meters) of troops bivouacked, training, and/or maneuvering on the installation.
- 11. Hunt within 164 yards (150 meters) of Natural Resources Management Branch hog traps.
- 12. Shoot at birds or animals on utility lines or supporting poles.
- 13. Shoot at or hunt protected birds to include: hawks, owls, eagles, all nongame birds, and all songbirds. See TPWD Outdoor Annual for unprotected birds.
- 14. Possess a handgun on Fort Hood except when legally stored at a domicile or in legal transit to and from a range activity.
- 15. Hunt with or possess a rifle in live fire or maneuver training areas except as authorized on the guided rifle hunt.
- 16. Hunt with a rim fire rifle.
- 17. Possess a firearm while archery deer or turkey hunting.
- 18. Trap, except as authorized, fur-bearing animals.
- 19. Hunt with and/or run dogs/ birds of prey without a valid Fort Hood hunting permit and appropriate state and federal permits.
- 20. Engage in or participate in the act of hunting while consuming alcohol or drugs, while impaired or intoxicated. Any person who is determined to have consumed alcohol less than eight (8) hours prior to hunting activity will be denied the opportunity to hunt and appropriate action will be taken. Refusal to consent to a blood alcohol test or breathalyzer test will result in an immediate suspension of hunting privileges.
- 21. Hunt migratory game birds with the aid of bait (minerals, vegetative material, or any other food substance placed to lure/entice).
- 22. Pursue, drive, flush, or otherwise harass wildlife and livestock with vehicles.
- 23. Harass other hunters while hunting.
- 24. Hunt any posted "No Hunting" areas.
- 25. Hunt with or possess a privately owned weapon within unimproved areas without a valid Texas hunting license, Fort Hood hunting permit, AACC permit, firearm registration, and proof of hunter education certification.
- 26. Possess shotgun slug load within unimproved areas without a valid Teletrac/Hunt Control Clearance.
- 27. Possess/use buckshot within unimproved areas EXCEPT for feral hog hunting.
- 28. Discharge a firearm into, across, or at water surface except during legal waterfowl hunting.
- 29. Hunt game animals or non-game animals with a vehicle powered light source.
- 30. Use chemicals, smoke, or petroleum products to evict or "gas' snakes and other reptiles or amphibians from caves, crevices, sinkholes, or other den sites.
- 31. Use pellet or B.B. guns in training areas.
- 32. Shoot targets, except at Pilot Knob Sportsman's Range
- 33. Transport muzzle-loading weapon with percussion cap/primer attached to the weapon (made ready to fire).
- 34. Trapping feral hogs.
- 35. Hunting hogs with dogs.
- 36. Release or introduce animals of any species on Fort Hood without written permission from DPW/Natural Resource Management Branch.

NOTE: Hunting violations can result in one or more of the following penalties:

- ❖ 7 days suspension
- ❖ 30 days suspension
- Criminal prosecution and/or suspension/revocation of hunting privileges for a designated period of time or indefinitely

Dove, Quail, Ducks: See Texas Parks & Wildlife Outdoor Annual and Publications **Feral Hoq, Other Small Game and Non-Game Species**: No closed season.

AREA DESIGNATIONS FOR THE GENERAL SEASON

Guided Live Fire Training Areas:80/81, 82 East, 82 West, 83/84, 85, 86/87N, 87S/88, 89, 90, 91, 92/93 Range Control has the final determination on whether a LFTA is open or closed.

<u>Guided Rifle Areas:</u> 41, 42, 43/44, 45/46, 47/48, 70, 71, 73. Multiple areas put together are considered one guided area.

<u>Guided Shotgun with slug or Muzzle-loading Areas</u>: 72, 201/202, 301/302/303/304. Multiple areas put together are considered one guided area.

<u>Unguided Areas/Shotgun with slug, Muzzle-loading, Archery or Crossbow (Rifles not authorized):</u> 10, 11, 12, 20, 21, 22, 23, 115, 50, 51, 52, 53, 60, 61, 62, 63, 64, 65, 66

Archery Only Areas: 8A (North), 100, 101, 102, 106, 107, 108, 109, 200, 203, 300, 305, 306

Note #1: Turkey hunters may use shotguns with bird shot in Area 8 (North & South), 109, 200, 203, 300, 305, and 306.

Note #2: For Area 203, no hunting is authorized in Camp Finlayson.

Note #3: Areas 106 & 107 requires a written clearance obtained at the Sportsmen's Center for both scouting and hunting.

<u>Unguided No permanent stands and No feeders areas</u>: 13 & 40 (all limited range weapons), 112 & 116 & Q4 & Q5 (Archery Only). You may utilize portable stands or blinds; however, you **must** take out every day. You may utilize natural blinds (cedar limbs for example) but you must take down every day. No feeders are authorized in these areas; however, you may throw bait on the ground.

<u>Small Game Areas:</u> During the Fall General Season, all available unguided big game areas will have joint utilization with small game hunters. Big game Archery Only areas authorized to have small game hunters hunting

with shotguns/shot shells for small game are: 8, 109 (North of the 40 gridline and East of the 12 gridline), 200, 203, 300, 305, 306. All other designated Archery Only Areas are not authorized firearms use at any time.

NOTICE: All area designations, access to Fort Hood lands and hunting schedules are subject to change without prior notice based on current Force Protection status or at the convenience of the government.

NOTE:

- 1. No pistols of any kind are authorized in any type of hunting on Fort Hood.
- 2. No BB or pellet guns are authorized in Fort Hood training areas.

SMALL GAME, FERAL HOG AND NON-GAME HUNTING

(All game except whitetail deer, axis deer, black buck antelope, and turkey.) Hunters will abide by seasons, bag limits, and authorized weapons as well as all State and Federal hunting laws and regulations.

All hunters must log in with the Sportsmen's Center's automated Teletrac system telephonically before entering any numbered training area. (See Area Access Hunting TeleTrac instructions for making reservations.) You must use your Area Access Permit number to utilize this system to gain access for small game hunting, not your hunting permit number. All hunters must log out with the TeleTrac system when they have finished hunting.

During the Fall General Season, small game hunters are only authorized into Guided Areas between 10 am and 2 pm <u>or</u> 10 pm and 0300, **on scheduled guided hunt dates**. Normal access is authorized during nonguided hunt dates. Small game hunters going into Guided Areas **on guided hunt dates** between 10 am and 2 pm must select Option 4 in the Teletrac system.

If authorized by current Force Protection status, raccoon hunting, coyote hunting and feral hog hunting at night is authorized.

Feral hogs (unlimited harvest) harvested during the Fall General Season are **required** to be brought directly to the check station for weighing, inspection, and record keeping by DPW/ Natural Resource Mgmt. Branch (NRMB). Feral hogs harvested outside of the Fall General Season, will be brought to the check station as well during normal business hours (0730-1630 Monday-Friday). **Other than normal hours**, when the check station is not manned, hunters **must register their harvest** by completing the appropriate paperwork that will be located in a drop box adjacent to the check station. Instructions will be posted on-site regarding proper procedure. Hunters who would like to have their harvest weighed and measured may attempt to contact the on-duty Game Warden, 535-1050, or may return to the check station during normal business hours.

Hunters taking or hunting migratory game birds must have all appropriate endorsements on their Texas State Hunting License.

Fort Hood regulations govern waterfowl hunting on streams and impoundments within Fort Hood and that portion of the Leon River that borders the military installation. Fort Hood regulations do not regulate waterfowl hunting on Belton Lake or that portion of Cowhouse Creek east of East Range Road (Curry) Crossing, provided access to these locations is by boat and hunters do not exit the boat. Access to hunt on the Belton Lake shoreline is controlled through AACC. Hunters must use non-toxic shot loads for all waterfowl hunting on Fort Hood.

Waterfowl hunters may access the "No check in/out ponds" (Airfield Lake, Clear Creek Lake, Copperas Cove # 2, Copperas Cove # 3, Engineer Lake, Heiner Lake, Larned Lake, and Nolan Lake) by the most direct route to and from the lakes. For safety reasons, waterfowl hunters will stay within 75 yards of the waters' edge. DO NOT wander beyond the 75 yards around the lake as there may be rifle or shotgun with slug hunters utilizing the same area. There is NO hunting at Cantonment A, Cantonment B, Landfill Lake, Birdbath Lake, Henry Lake, East Lake or Pershing Lake.

Waterfowl hunters will pick Option 4 on the Teletrac system to log in/out of hunting areas. Waterfowl hunting reservations will be made for one day only! You may choose a maximum of 3 open areas.

Hunting non-game animals (e.g. coyotes) with the aid of electronic calling equipment or other calling means is authorized. Use of calling equipment or other calling means is also authorized for recreational purposes other than hunting such as photography. Hunting of coyotes is authorized with shotgun with slug or muzzle-loading firearms. Use Option 4 on Teletrac system.

Area 109 is Archery Only for BIG Game (deer & turkey) hunting. Small game hunting will only be authorized using shotgun and shot shells (see Table 2-1 for game/weapons limitations) North of the 40 gridline and East of the 12 gridline.

Mountain lions are protected on Fort Hood and may not be hunted.

FUR-BEARING ANIMALS

In addition to the requirements listed on page 13, hunters and trappers of fur-bearing animals must possess a valid Texas Trapper's License and a Texas Parks and Wildlife Department non-game permit as required by the state. Only live traps are authorized on Fort Hood.

It is prohibited to use foot holding (steel leghold or Conibear), deadfall, snare, pit-fall, or net traps. Each trap must be marked in an indelible medium with the trapper's name, address, and Fort Hood Area Access Permit number, and be checked a minimum of once every 36 hours.

UNGUIDED ARCHERY DEER & TURKEY HUNT PROGRAM

All hunters must have a valid State Archery Endorsement indicated on the Texas State License. All persons are authorized to use crossbows during the Archery Only Season. Archery hunters are required to pass the Bow Proficiency Test, administered by Sportsmen's Center/Hunt Control, Bldg. 1937. Hunters passing the Bow Proficiency Test will have it annotated on their Fort Hood Hunting Permits. There is a \$3.00 fee for qualifications. Hunters will be required to qualify every year unless they have recorded a deer harvest by archery the previous season (must show last year's permit as proof.) Bow qualification will be with broadheads. The Adult Bow Qualification Course consists of 2 targets (2 different distances, 20 yards and 30 yards.) Adults must hit a minimum of two out of three arrows in a nine-inch circle at BOTH distances to qualify. Qualifiers 8-14 years old will shoot from 20 yards and must make 4 out of 6 arrows in a nine-inch circle. Traditional bow hunters will meet the same qualification standards as youth. Practice shots are not permitted during a qualification test. No more than two attempts will be allowed per day. If you do not qualify on your first try, you will have to go to the end of the line to try again. Qualification times beginning 15 August 2010 are between 11 am and 2 pm. Other qualification times may be available closer to the Archery Season.

Hunters must bring all harvested deer and turkey directly to the Natural Resource Mgmt. Branch/Game Check Station (Bldg. 1944) to be inspected and recorded. Deer must be field dressed in the hunting area. Turkeys must remain whole for inspection and recording. Any feral hogs harvested during the Archery Only Season will also be field dressed and brought to the Game Check Station. All whitetail deer and turkeys must be legally tagged in the field. All hunters hunting turkey must have a State Upland Game Bird Endorsement indicated on their hunting license. During the Archery Only Season, all available training areas as well as the Archery Only areas will be utilized for hunting.

Instructions for Unguided Big Game Hunting TeleTrac Reservations: Phone numbers are (Area Code 254): 285 - 6049, 6050, 6051, 6052, 6053, 6054, 6055. Other series of numbers: 553-0237, 0239, 0241, 0242. Other series of numbers: 288-4163, 4164, 4165, 4166.

NOTE: If the number you are dialing does not answer, dial a number from another series. Periodically a series of numbers will be inoperative however the other series will work.

- 1. Dial one of the telephone numbers; the next available line will pick up.
- 2. To check in or out push 1.
- 3. Punch in your Area Access Number followed by the (#) pound sign.
- 4. Press 2 for unguided.
- 5. Punch in your area selection code just as it appears on the code table, making sure to include all symbols. A voice will repeat your area selection; press 1 if correct or press 2 to reenter. Do not push the keys too fast or the system will not recognize your selection. There is a voice prompt for the next number/letter. You must always push the # key at the end of your selected area code.
- 6. Press 1 for today or press 2 for tomorrow.
- 7. The voice will verify your reservation area and day. Hang up if done.
- 8. A voice will ask if you want to check someone else into the same area, press 2.
- 9. Put in the new Area Access Permit number followed by the # sign and continue to follow the prompts.
- **10.** An individual may select only one area in the unguided hunt program. **An individual may only have one** reservation at any given time in the unguided program.
- 11. Areas 106 and 107 can only be accessed with Sportsmen's Center written clearance for scouting and hunting. Written clearances only available during normal business hours.

GUIDED RIFLE DEER & TURKEY HUNT PROGRAM

All guided hunts start at the Sportsmen's Center. All hunters must physically check in at the Sportsmen's Center. Guide cards (harvest cards) will be randomly checked for accuracy and accountability at Hunt Control discretion.

Deer Guides will lead hunters participating in this program to their assigned hunting area and post hunters to their stands. Hunters may select a stand and guides will try to be accommodating; however, the guide has final say based on range, vehicle type, quota, stand

rotation and weather. There will be no stalking of game during the Guided Hunt. Guided hunters must remain at their assigned deer stand. Even when tracking wounded game, hunters will not leave sight of their stand or 100 yards; whichever is the shorter distance. If wounded game goes beyond this limitation, hunters should mark the last spot where the wounded game was seen and wait for their guide to assist in tracking. Guides will meet with posted hunters at their deer stands or at designated rendezvous points as closest to the designated pick up time as tracking of game and other duties allow. Even if the Deer Guide is considerably late, hunters are not authorized to leave their assigned hunting stand or rendezvous point. The Deer Guide will make every effort to pick up hunters in a timely manner barring any unforeseen circumstances. Guides will return with all hunters who have harvested game to the Game Check Station where game will be inspected and recorded. Hunters who have not harvested any game can be released from the Guide's designated rendezvous point. The released hunter/hunters must immediately leave the area; at no time may he/she reenter the training area for ANY reason once released. This privilege will be discontinued if abused.

All whitetail deer (field dressed) and turkey (whole) must be legally tagged in the field. Guides will ensure that State tags are properly filled out and attached to game prior to leaving hunting stands. Reminder: the hunting license harvest log for white-tailed deer must be filled out on the back of the state license. **The hunter** is ultimately responsible to make sure his/her state tag and log are properly completed and attached to the game.

Hunters will be asked to drive their privately owned vehicle (POV) to the Guided Hunting Area. Hunters making reservations for LFTAs must have a 4-wheel drive vehicle. Potluck hunters without 4-wheel drive vehicles will be accommodated based on Sportsmen's Center and LFTA guide discretion. Hunters driving their POV will be escorted to the assigned hunting area and posted by a Deer Guide in his own POV. The Deer Guide will designate a rendezvous point after the predetermined hunt period has concluded. To ensure the safety of all participants, hunters **may not** leave their assigned area unless released by the deer guide. Leaving an assigned stand beyond limits established by the guide (including the pursuit of wounded game) is prohibited. Hunters must obey their guide's instructions on hunting rules, safe lanes of fire, shooting hours, and other restrictions. All hunts in Live Fire Training Areas will be guided.

Only one, armed hunter will be allowed on a stand. Hunters under the age of 15 years **must be accompanied** by an unarmed individual 18 years of age or older who possesses a valid Fort Hood Hunting Permit, valid State Hunting License, Area Access Permit and Hunter Education certification. Others may be accompanied only as authorized by the Sportsmen's Center and the Game Warden Office.

Bow (archery or crossbow) hunters desiring to hunt in the Guided Areas may bring a pop up blind, hunt an established stand or coordinate with the chief guide prior to season for stand location. No unguided bow hunting will be conducted in the Guided Areas during the week when there are no guided hunts during the General Gun Season.

The hunt proceeds until harvest quotas are met, the last scheduled hunt day, or as determined by the DFMWR.

GUIDED LIMITED RANGE HUNTS

Authorized limited range firearms are indicated in the FH Circular 210-10-22 Table 2-1 located in this guide. All other guidelines as outlined in the Guided Rifle Deer & Turkey Hunt Program above pertain to this hunt program. The Guided Limited Range Weapon Hunt Program will be conducted in the same manner as the Guided Rifle Deer & Turkey Hunt Program except for the weapons limitation.

GUIDED YOUTH HUNT PROGRAM

Hunters must be between the ages of 8 and 16 on the Youth Hunt dates. An unarmed escort 18 years or older must accompany each youth hunter. **Escort and youth** must both possess a valid Fort Hood Hunting Permit, Area Access Permit, State Hunting License and Hunter Education certification.

Youth hunters should be registered prior to 29 October 2010 in order to have adequate guides. Any hunter that fails to register may report for the hunting assignments at 1800 hrs. 29 October 2010. They will be assigned after those registered, providing space is available.

Hunters will be randomly selected for each day of hunting, October 30 and October 31, by computer. Youth hunters do not have to be present for area assignment; however, the escort must be present. Youths of guides will automatically be assigned to the guides' area and will not be part of the assignment process.

Area of preference will be established at the time of assignment. No hunter will be allowed to participate in this program without an adult escort 18 years or older. Youth hunters who do not have an available escort may request a volunteer deer guide escort at time of registration.

Any hunter wanting to hunt the PM only period must make his/her wishes known at the time of area assignment and report to Sportsmen's Center (Bldg 1937) prior to 1400 hours, on the day of the desired hunt. Hunters will be given a sequence of assignment by computer. Hunters will be assigned to areas as openings are available. Guides, at the conclusion of assignment, will instruct hunters and escorts. Hunters/escorts will be instructed on all aspects of the hunt and on the assembly time and location at the Sportsmen's Center on the day of the hunt. Guides will meet hunters and escorts and lead them to their hunting area. Harvest limits during the Youth Hunt Program, will be determined by DPW/NRMB and the Sportsmen's Center based on the deer census.

UNGUIDED YOUTH HUNT PROGRAM

Hunters must be between the ages of 8 and 16 on the Youth Hunt dates. An unarmed escort 18 years or older must accompany each youth hunter. **Escort and youth** must both possess a valid Fort Hood Hunting Permit, Area Access Permit, State Hunting License and Hunter Education certification.

Youth hunters should be registered to hunt prior to 30 October 2010. Any hunter that fails to register may still purchase permits during regular Sportsmen's Center business hours on the days of the Youth Season. Once permits are activated, they can make unguided reservations in the TeleTrac system.

GUIDED DISABLED VETERANS HUNT PROGRAM

The Disabled Veterans Hunt Program was established to ensure equal opportunities are available for DV hunters to participate in Fort Hood's hunting programs. A DV hunter is so designated by Army regulations and the Department of Veterans Affairs. To hunt as a DV hunter you must have all licenses, permits, Hunter Education Certificate, and Area Access Permit as required by regulations.

DV hunters will be assigned hunting areas by the same procedures as regular hunters. If hunting from a vehicle, a DV hunter must be pre-registered with the Sportsmen's Center and the Game Warden Office. DV hunters hunting from their vehicle, who wish to participate in the Unguided Hunt Program, will be assigned hunting areas by the same procedures as regular hunters. DV hunters wishing to participate in the Guided Hunt Program will be required to report to Sportsmen's Center at 0300 hours (0400 after opening weekend) or 1400 hours (for respective hunts) for area assignments. Not every area may be accessible to DV hunters. Only those areas that are available on the day of the hunt will be assigned.

In guided areas where a DV hunter is assigned the guide will escort the DV hunter to and from the hunting area. Guides are only required to assist DV hunters in the same manner as they would any other hunter. DV hunters requiring special assistance must be escorted by an adult 18 years of age or older. DV hunters must provide their own escort if this is the case. Designated non-hunting escorts must have an Area Access Permit. Guides will place DV hunters in a stand or in a location where the DV hunter may hunt from his/her vehicle. The Chief Deer Guide of the area will establish the vehicle parking location. DV hunters are not authorized use of ATVs.

GUIDED HUNTER ASSIGNMENT WITH TELETRAC

Beginning November 04, 2010 at 1600, hunters wishing to participate in the Guided Hunt Program can make a reservation for opening weekend.

TeleTrac will only log reservations by a valid **Area Acess Permit** number. Only one guided hunt reservation will be authorized at any given time. If a hunter wishes to change his/her area selection, the hunter must call the TeleTrac system to log out of the current reservation then make another area selection. Hunters must keep in mind that the area they wish to change to may not have any slots available.

When hunters call the TeleTrac system they will be guided through the selection process offered by the menu. Hunters assigned to any areas that change from an open status to a closed status due to troop movement

and training, as determined by G3 Range Division, will be able to call the TeleTrac system to **clear** the original reservation and make another selection.

Morning guided hunters must check in with his/her assigned area guide at the Sportsmen's Center **by** 0300 hours opening weekend (0400 thereafter) and afternoon guided hunters must check in **by** 1400 hours. Any hunters failing to check in with their assigned area guide at the proper time must go potluck in order to hunt. Promptness will avoid a missed hunting opportunity. If you have difficulty locating the guide for your selected area ask for assistance.

All no-show hunting slots will be filled with potluck hunters. Order of assignment will be determined by a random drawing. Hunters are responsible for reporting at their assigned location at designated departure time.

Guided hunters must clear the TeleTrac system **first** in order to make another guided reservation. TeleTrac **does not** automatically clear reservations. There is no penalty for not clearing a guided hunt reservation since it is a controlled hunt.

Guided hunters desiring to only hunt in the afternoon must first make a reservation through TeleTrac; then call the Sportsmen's Center so we can annotate this request. The reservation will be lost if the Sportsmen's Center is not notified.

GUIDED RESERVATION INSTRUCTIONS:

- 1. Call the TeleTrac system by dialing one of these numbers (Area Code is 254 if calling long distance); the next available line will pick up: **285** 6049, 6050, 6051, 6052, 6053, 6054, 6055 **Other series of numbers: 553-** 0237, 0239, 0241, 0242. **Other series of numbers: 288-**4163, 4164, 4165, 4166
- 2. To check in or out of an area push 1.
- 3. Enter your Area Access Number followed by the (#) pound sign.
- 4. Push 1 for guided.
- 5. Enter your selected area as shown on Gun Season code table, making sure to enter all symbols as shown. Do not push the keys too fast or the system will not recognize your selection. There is a voice prompt for the next number/letter. You must always push the # key at the end of your selected area code.
- 6. A voice prompt will ask you if the selected area is correct, push 1 if correct or push 2 to reenter.
- 7. A voice prompt will ask you to select the date of your reservation, punch in the date now (example 1106 = November 06, 2010).
- 8. The voice will verify your area selection and date. Hang up if done.
- 9. A voice will ask if you want to check someone else into the same area, press 2.
- 10. Put in the new Area Access Permit Number followed by the # sign and continue following prompts. There is a limit of (2) reservations per phone call. You must hang up and call again to make any more reservations. WARNING: If you push a button to circumvent the opening message too soon, the system will just take you in a circle and you will not be able to check out of an area without hanging up and dialing again. You must check out of an area before making another reservation. Each hunter is only authorized (1) one guided reservation at a time.

VOLUNTEER DEER GUIDES

Hunting Guides:

Hunting guides should be familiar with FH REG 210-25, III Corps & FH Circular 210-YY-22, Texas
Annual Hunting & Fishing Guide, and the DFMWR Annual Hunting, Area Access & Fishing Guide.

Summary:

This appendix provides instructions for guides during the Fall Deer & Turkey hunting season.

Appointment:

- The volunteer deer guides are selected by the Deer Guide Selection Committee.
- A chief guide and an appropriate (determined by Sportsmen's Center) number of assistant guides are appointed to each guided hunting area utilized.

Qualifications:

- The position of hunting guide is strictly voluntary and a position of responsibility and authority not of privilege.
- Guides must set an outstanding example of personal conduct and sportsmanship while participating in the Fort Hood Hunt Program and executing their duties. Guides can be dismissed for failure to comply with all regulations and policies and/or unsportsmanlike behavior.
- Guides must have complete knowledge of the assigned hunting area to include:

- Authorized stand locations, to include routes to and from stands.
- Entry and exit of area.
- Area boundaries.
- Safe firing lanes for each deer stand.
- Guides must possess a thorough knowledge of state and installation hunting regulations and comply with the same.
- Guides must possess a Texas hunting license, a Fort Hood hunting permit, and an Area Access Permit.
 Guides must be certified in a state approved Hunter Education Course. The only exception is if a guide is not going to hunt, then the requirements are Hunter Education Course certification and an Area Access Permit.
- Guides **must not** have had a conviction for any violation of state or federal game laws. Other violations will be considered on a case-by-case basis.
- Guides must have at least two years of experience in the same area as an assistant guide prior to
 applying for chief guide status. Guides must have at least two years guide experience to apply for
 another area's chief guide position should one come open and no assistant guides in that area
 applied for the chief guide position.
- Guides are courteous and helpful to all hunters at all times, but are not required to render personal service to hunters, such as cleaning game.
- Effective 2005-2006 season, guides must be 21 years of age or older or already on the guide roster.
- A guide's performance to include attendance, stand conditions, and any incidents will be considered during the selection process. Seniority will not be the sole criteria for selection.
- Live Fire Training Area guides must have use of a four-wheel drive vehicle and a cell phone.
- No more than 25 percent of the guide roster can be represented by unaffiliated civilians. Exceptions may be necessary during periods of deployment.

Duties and Responsibilities:

- Duties and responsibilities of guides listed in this paragraph are not all inclusive. Many duties evolve due
 to a guide's position of responsibility.
- Guides must be present at the designated time and place of meeting when their assigned area is open for hunting.
- Orient assigned hunters to state and installation hunting regulations, emphasizing safety and prohibitions.
- Check assigned hunters before departure for proper documentation and that firearms and ammunition conform to Fort Hood hunting regulations. All weapons must be empty (unloaded), be cased, or have bolts open until the hunter is on a stand.
- Hunters may not possess or be under the influence of intoxicants. Violators must be reported to the Hunt Control Office prior to departure.
- All hunters must wear 400 square inches of international orange (not red). Hunters not wearing orange will not be allowed to depart for hunting areas.
- Escort assigned hunters to the hunting area and assign hunters to stands. Instruct hunters on authorized kill, shooting hours, the safe area in which hunters may shoot or move about, and unloading weapons before the guide returns.
- Inform hunters that they will be picked up as soon as possible after legal shooting hours at the end of
 each hunting period and at no time are they (hunters) authorized to leave the hunting area without being
 released by the guide.
- Inform hunters of the designated meeting place after the hunt, and account for all hunters. Only release
 hunters who have not harvested game once accounted for. Inform released hunters that they are NOT
 authorized to reenter the training area for ANY reason once released.
- If tracking game after normal reporting time, notify the Sportsmen's Center.
- The designated guide for each area will present to the Hunt Control Office, a completed FH Form 210-X3 (furnished by Hunt Control), including area number, name, **HUNT** permit number and assigned stand of every individual assigned to each area. Guides are authorized only one guest per hunt period. Only the Hunt Control Office representative assigns additional hunters to an area and records the name and permit number on the FH Form 210-X3.
- Records the harvest of each hunter on the FH Form 210-X3. These forms must be turned in to Hunt Control at the end of each hunt day. FH Form 210-X3 must be filled out in its entirety. No harvests will also be annotated.

- Guides will not place hunters in "OFF LIMITS" or "NO HUNTING" areas as indicated on the AACC official hunting map.
- **DO NOT** place hunters on stands with the field of fire covering any portion of the reservation boundary fence, Belton Reservoir, cantonment areas, recreation and picnics areas, and maintained roads.
- Supervise tracking and recovery of wounded deer and turkey and instruct hunters **not** to track wounded game beyond the hunter's safe area before the guide returns. "Safe Area" defined as sight of deer stand or 100 yards, whichever is the shorter distance.
- Instruct hunters to avoid taking long shots or running shots and to report all shots fired. Look for signs of possible hits even if the hunter thinks the shot missed.
- Report unsuccessful attempts to track wounded game to Natural Resource Branch or Game Warden.
- Must carry a good, strong flashlight on afternoon hunts to aid in recovery of wounded game.
- Ensure that hunters complete their state license as required. Ensure that hunters properly affix their state tag to all big game harvested while in the field. Escort hunters with a harvest to the Natural Resource Management Branch Game Check Station (Bldg. 1944) for weighing and record keeping.
- The chief guide of each guided area is responsible to the Hunt Control Office for scheduling of guides for each scheduled hunt day that the area is open for hunting. Scheduled guides must check in with the Hunt Control Office by phone (254-532-4552) or in person no later than 1500 on the day before serving as a guide.
- The chief guide for each numbered training area is responsible for the construction and maintenance of deer stands. Furnishes Hunt Control with grid coordinates of numbered hunting stands before the hunting season begins. Only identified hunting stands will be used during the guided hunt program. Chief guides are responsible for the removal of old stand material or consolidation of the material for pick up during Spring and Fall cleanup.
- Minimal requirements for any deer stand constructed by any deer guide for use during the guided hunt program:
 - Single hunter: 3 feet x 3 feet platform
 - Double hunter: 4 feet x 4 feet platform
 - Windshield construction of canvas or lumber and a footrest if hunter's legs will hang from stand.
 - Sound in construction.
- Must report violations of state or installation regulations to a game warden or the Hunt Control Office.
- Guides may hunt while on duty, subject to the limitations prescribed for all other hunters.
- Gear tags required for all personal hunting equipment left in the field. Tag must have name, area placed in and date placed. Tags should be as durable as the equipment.
- Guides should be cognizant (aware) of archery hunters during prime hunting times and try to avoid disturbing the archery hunters while maintaining stands in their assigned area.

Hunter to Guide Assignments:

- The Hunt Control Office assigns hunters to guides according to:
 - All hunters escorted or taken to hunting areas must be assigned through the Hunt Control Office.
 - Hunters under 15 years of age must be accompanied on a stand by an unarmed individual who has a valid Fort Hood hunting permit and other required documentation, and who is 18 years of age or older. Persons under 8 years of age may not hunt in the Guided Hunt Program.
 - Guides may take one properly documented guest to hunt providing Hunt Control is notified prior to the assignment of hunters to guides.
 - Guide cards (harvest cards) will be randomly checked for accuracy and accountability at Hunt Control discretion.

UNGUIDED DEER & TURKEY HUNT PROGRAM

Unguided Deer & Turkey Hunt Program will be conducted concurrently with the Guided Deer & Turkey Hunt Program and will follow the same safety and procedural guidelines with the following exceptions:

a) Turkey is classified as Big Game, turkey hunters in the SE Region will continue to check in/out through Teletrac; selecting Option 2 for unguided Big Game hunting. This procedure is for turkey hunting only. Under no circumstances is hunting of whitetail deer authorized in the South East Deer Management Region; all violators will be prosecuted.

- b) Unguided Program will be available 7 days a week as area availability allows except when the Sportsmen's Center is closed.
- c) Unguided Program will be with limited range weapons as indicated in the FH Circular 210-10-22 Table 2-1. NO RIFLES ARE AUTHORIZED IN THE UNGUIDED PROGRAM.
- c) Unguided hunters must have a valid area assignment through the TeleTrac system; however, they may go to their assigned area on their own timeline between 0400 and 2100 on their valid reservation date.
- d) Unguided hunters are responsible for clearing their assigned hunting area by 2100 hours daily. Hunters not cleared by 2100 hours will be referred to the Game Warden Office. Hunters who are tracking game past 2100 must notify the game warden on duty 254-535-1050.
- e) No Unguided hunters will be authorized in the Live Fire Training Areas at any time.
- f) Hunters are required to bring all harvested big game and hogs (see Small Game Hunting section) to the Game Check Station for inspection and recording immediately after leaving the hunting area. All big game must be legally tagged in the field. Field dress all deer, hogs and exotic game but do not field dress turkeys until they have been checked in. Unguided hunters may harvest one big game animal per species, per hunting session. Unguided hunters may harvest more than one big game animal per species per day; however, the first animal must be checked in prior to harvesting the second. DO NOT leave carcasses in the field or remove from the installation without clearing the DPW/Natural Resource Mgmt. Branch Game Check Station.
- g) Unguided hunters must know the authorized deer harvest quota they are hunting. Deer harvest quotas are updated daily on the DEER QUOTA HOTLINE 254-532-9425.
- h) Unguided hunters may take a registered **non-hunting**, **unarmed observer** to an unguided area while hunting. Observer is defined as an individual not actively participating in the hunt; only present to watch. All children observers must be in the sponsor's direct line of vision. This authorization has been established to introduce novices to hunting and to accommodate persons with disabilities who require assistance.
- i) DFMWR will not provide deer stands in unguided areas for the Fort Hood Hunt Program. Individuals may construct or buy deer stands for placement in unguided areas. Permanent stands in unguided areas will be available to all other hunters who are assigned to unguided areas. No locks, chaining access ladder to a tree or other means to prevent use will be authorized on any permanent deer stands in the unguided areas. Any permanent deer stand placed in the unguided areas found locked or secured by other means to prevent use, will have the locks/means removed. There is no guarantee to any individual hunting in an unguided area, that any specific deer stand will be available to him/her on any given hunt day. Hunter ethics, hunter etiquette, good sportsmanship, and respect are strongly encouraged. No permanent stands/blinds or feeders are authorized in Unguided Areas 13, 40, 112, 116, Q4, and Q5.
- j) It is at each individual's own risk, whether to place and utilize a permanent or portable stand in an unguided area. There are no guarantees to availability for permanent stands and there are no guarantees that portable stands will remain where placed if not removed daily.
- k) All personal equipment: portable stands, game cameras and feeders will be affixed with a legible and easily located Gear Tag. Tag must have name, area placed in and date placed. Tags should be as durable as the equipment. Phone number is also recommended.
- Malicious damage/vandalism incurred to deer stands or personal equipment should be reported to the Game Warden Office using the same procedures as damage caused to government property. Verified violators will be prosecuted to the fullest extent of the law. DFMWR will not be responsible for any said damage to personal equipment (identified above) used in the unguided areas.
- m) **Definition of permanent deer stand:** Any type of stand/blind constructed of wood or similar material, with or without legs/tower, intended to be placed in a "fixed" position (whether on the ground or in a tree), not intended for daily removal, and not readily (easily) moveable by one person. **If not removed daily, the stand was not intended for daily removal.**
- n) **Definition of portable stand:** Any type of hand-made or purchased stand/blind intended for temporary placement (whether on the ground or in a tree), may or may not be collapsible, intended for daily removal, and readily (easily) moveable by one person.
- o) **Definition of Gear Tag:** A tag constructed of material as durable as the device to which it is attached. The gear tag must be legible, and contain the Name of the person using the device and the date and area the device was set out. Phone number is also recommended.

UNGUIDED HUNTER ASSIGNMENT WITH TELETRAC

Commencing at 1600 hours on 05 November 2010, hunters wishing to participate in the Unguided Hunt Program will be able to call the TeleTrac automated system and obtain a slot to hunt in an unguided area. Hunter assignments will be valid for the **next day** from 0400 to 2100 hours.

TeleTrac will only log hunter assignments by valid **Area Access Permit** numbers. Only **one** unguided hunter assignment will be authorized at any given time. If a hunter wishes to change his/her hunting assignment, the hunter must call the TeleTrac system to log out of the current assignment and then make another selection. Hunters must keep in mind that the area they wish to change to may not have any slots available.

When hunters call the TeleTrac system they will be guided through the selection process offered by the menu. Hunters assigned to any areas that change from an open status to a closed status due to troop movement and training, as determined by G3 Range Division, will be able to call the TeleTrac system to clear the original reservation and make another selection.

All hunters must call the TeleTrac system to clear their hunting area by 2100 hours daily. After 2100 hours, any hunters not cleared in the TeleTrac system will be referred to the Game Warden Office. The first offense will result in a warning, second offense/7 days suspension, third offense/30 days suspension, and fourth offense/suspension for remainder of season. Hunters tracking game after 2100 must notify the game warden on duty 535-1050.

UNGUIDED RESERVATION INSTRUCTIONS:

- 1. Call the TeleTrac system by dialing one of these numbers (Area Code is 254 if calling long distance); the next available line will pick up: **285** 6049, 6050, 6051, 6052, 6053, 6054, 6055 **Other series of numbers: 553** 0237, 0239, 0241, 0242. **Other series of numbers: 288**-4163, 4164, 4165, 4166
- 2. To check in or out of an area push 1.
- 3. Enter your Area Access Number followed by the (#) pound sign.
- 4. Push 2 for unguided.
- 5. Enter your selected area as shown on Gun Season code sheet, making sure to enter all symbols as shown. Do not push the keys too fast or the system will not recognize your selection. There is a voice prompt for the next number/letter. You must always push the # key at the end of your selected area code.
- 6. A voice prompt will ask you if the selected area is correct, push 1 for yes or push 2 to reenter.
- 7. A voice prompt will ask you to select today or tomorrow, push 1 for today or push 2 for tomorrow. Due to unpredictable area availability, these are the only two options for unguided hunting. Guided hunters may make reservations further in advance since they must still meet at the Sportsmen's Center and would be notified of area closures.
- 8. The voice will verify your area selection and date. Hang up if done.
- 9. A voice will ask if you want to check someone else into the same area, press 2.
- 10. Put in the new Area Access Number followed by the # sign and continue following prompts. There is a limit of (1) reservation per permit. There is a limit of (2) reservations per phone call. You must hang up and call again to make any more reservations.

<u>WARNING:</u> If you push a button to circumvent the opening message too soon, the system will just take you in a circle and you will not be able to check out of an area without hanging up and dialing again. You must check out of an area before making another reservation.

SPRING TURKEY HUNT PROGRAM (THIS PROGRAM IS UNGUIDED)

The Spring Turkey Hunt Program is an unguided hunt program. Hunters wishing to participate in this program will be responsible for clearing their assigned hunting area by 2100 hours daily. Hunters not cleared by 2100 hours will be referred to the Game Warden Office. As in the Fall Unguided Deer & Turkey Hunt Program **NO RIFLES** are authorized to harvest spring turkeys.

In an effort to give the youth a better chance of harvesting a turkey during the Special Youth Season March 26 & 27, 2011, adults pre-scouting for turkey are asked NOT to call turkeys for these two days.

Hunters are required to bring all harvested big game to the Game Check Station for inspection and recording immediately after leaving the hunting area. All big game must be legally tagged in the field. Do not field dress turkeys prior to inspection. Hunters desiring to hunt in the Live Fire Training Areas must be escorted by an individual whose name appears on the Live Fire Access Roster.

Check station hours will be 0730-1630 on weekdays and 0730-1630 on the first four weekends of the season. For the last three weekends of the season, the check station will not be manned. When the check station is not manned hunters must register their harvest by completing the appropriate paperwork that will be located in a drop box adjacent to the check station. Instructions will be posted on-site regarding proper procedure. Hunters who would like to have their harvest weighed and measured may attempt to contact the on-duty Game Warden, 535-1050, or may return to the check station during normal business hours.

The following Archery Only areas are authorized turkey hunting with shotguns with shot shells: 8A & 8B (North & South), 37, 109 (North of the 40 gridline and East of the 12 gridline), 200, 203, 300, 305, and 306.
